Maintenance and Operations -

Jim Freeman on vacation so Dale Webb reported on the maintenance and operations since the last meeting. Normal day to day operations. Hired Davis to replace a booster pump on Rasor Rd, Commissioner Satran-Loudin asked if we are responsible for the pumps? Webb replied there are 5 or so personal booster pumps that the District owns on Rasor. Alex is continuing with the meter replacements currently on Rasor Rd. Webb and Alex met with GC systems at the PRV vault and used our confined space gear so the PRV could be rebuilt. After it was done Webb and Alex have been up there twice adjusting the flow to the lower zone. The one ton has been picked up from Hudsons and seems to be much better. Monthly testing and billing for the Hydrant meters occurred and found the small unit had froze and busted (brought in by Joe w/DRK), repaired the unit and billed the repairs. Well 4 comms went down, and have been working on switching our SCADA to radio and eliminating the phone and data lines. As a result well 4 ran for over 24 hrs and was unable to alarm from Friday Morning to Saturday Morning when Dale caught it and shut it off and reset the points. Turned over the tank and we definitely have fresh water in the system from the upper zone now. Has been very busy and staff have been keeping up. Commissioner Pope commented that whatever we need for safety equipment we need to get the correct equipment for the job and not take any chances.
